Dear Petitioner:

Greetings in our Lord Jesus! Following what I am sure has been a period of serious discernment, you have chosen to begin the process of seeking a declaration of sacramental nullity of your previous marriage, a process some call 'annulment'. I would like to commend you on having taken this important step and pledge to you the Tribunal's assistance.

I would like to answer a few questions at the beginning. First, this process is quite different from the process of civil divorce. A civil divorce treats marriage like a civil contract and says that while the parties entered a valid contract, there is an adequate reason to end that contract and release them from their obligations. On the other hand, Jesus Christ himself taught that civil divorce is not to be practiced among His followers. Thus, if you were validly married, that marriage can be ended only by the death of one or both parties. If, however, the marriage was not validly entered by you, your former spouse, or both of you for one reason or another, than the marriage can be declared invalid (that is, inexistent) and the two of you free to contract a new marriage. The annulment process, then, looks not at what happened during marriage as much as it considers what the two of you brought to marriage. In other words, the period of dating, courtship, and engagement is of greater concern to the Tribunal. The period of marriage and its breakdown is only of concern as it reflects back on the period preceding marriage. You should keep this in mind as you complete the attached questionnaire.

Since an affirmative decision is not guaranteed and since the time can change significantly, depending on the cooperation of your witnesses, you are asked **not to schedule a date for a future marriage until the process is complete and you have received an affirmative decision.** The process will move quicker if you thoroughly complete the attached forms, submit the documents requested, submit the requested number of witnesses, and contact the witnesses in advance.

The address of the other party is essential to the process. Since the marriage took place between the two of you, the input of the other party must be sought by the Tribunal. The failure of the other party to participate in the process will not hinder or delay the process at all. However, he or she does have the right to be notified and to be invited to participate. It is not the responsibility of the Tribunal to locate your former spouse.

The participation of witnesses is also essential. The Tribunal process is a very real trial in which the truth of the matter is sought through the evidence brought forward by the parties. Because of the gravity of the matter, whether or not a true marriage existed, the Tribunal cannot merely take one party's word for it. Rather, witnesses who can describe the dating, courtship, engagement, and wedding of the parties are needed. Witnesses who can only describe the marriage or its breakdown are not particularly helpful to the process. The greater the number of witnesses the better.

Children and their status are in no way affected by this process. Your children, born to you and loved by you are yours. The identity of their parents is in no way doubted, and the mutual relationship of love and concern between parent and child is as untouched by the annulment process as it is by civil divorce.

A booklet has been developed by the Tribunal which explains each step in the annulment process and provides other useful information. If you would like to receive a copy of Annulment FAQ, please contact the Tribunal.

The Tribunal will notify you of each stage of the process. Though you are welcome to contact the Tribunal at any time, many of your questions can be answered by the advocate who is assisting you.

Lastly, I know that filling out this petition may prove difficult and even, at times, heart-rending. However, I hope that through this process you will experience a certain measure of healing and comfort; placing your feelings and recollections on paper may be a positive way of both objectifying them and beginning to let them go so that new life can begin.

**Agreement to Tribunal Policies and Practices**

The Policies and Practices of the Tribunal of the Diocese of Wheeling-Charleston are:

1. I understand that, if the Tribunal accepts my case for consideration, it does not and cannot guarantee an Affirmative decision will be given in the case.
2. I understand that the Tribunal cannot and will not ever promise or guarantee to conclude a case by a certain date. I agree to wait until I receive a final decision in writing before I set a definite date for remarriage within the Catholic Church, for the Convalidation (blessing) of an existing civil marriage, or being baptized or received into the Church.
3. I understand that the Tribunal, in the investigation of the case, may employ the services of a psychological professional or other expert witness and I hereby authorized the Tribunal to disclose complete information concerning my case to such a professional for case review. Upon completion of the case, I also authorize the Tribunal to release information regarding the case to a psychological expert, counselor, priest, or deacon for follow-up counseling as well as for premarital preparation presently or in the future. It is understood that otherwise all contents of this investigation will be kept confidential, reserved exclusively to the parties of the case and to the staff of the Tribunal, according to canon law of the Roman Catholic Church.
4. I voluntarily waive now and in the future any right under law (civil or ecclesiastical) to the subpoena or judicial discovery of the Testimonial Acts for this case. This waiver is given without reservation and condition. The purpose of this waiver is to provide for candor and openness in testimony and in recognition of the purely spiritual and religious nature of these proceedings.
5. I understand that the Tribunal's Presiding Judge will issue a decree binding all parties in this case to confidentiality. Accordingly, I agree to keep confidential and secret any information that I shall learn in the course of the proceedings. Because all testimony in this case is given for the possible ecclesiastical annulment of my marriage, and because my interest is solely to present my case to the Tribunal, I promise not to use information that I might learn through the case or, during the proceedings in any other forum (civil or ecclesiastical) or for any other purpose.
6. Please know that because of our deep concern for the safety of children and our firm commitment to keep them safe, we are obligated to report to the appropriate authority any and all instances of alleged abuse brought to our attention during this marriage.

### FORMAL PETITION CHECK LIST

The following papers and documents must be submitted to the Tribunal of the Diocese of Wheeling-Charleston together with the Formal Petition:

\_\_\_\_\_ Witnesses (*your parents and 4 or more additional witnesses; if your parents are deceased at least 6 other witnesses*).

***If any item is missing, DO NOT submit your petition to the Tribunal until you obtain the missing item. We highly recommend that you keep a copy of all documents and papers sent to the Tribunal.***

The first task of the Tribunal will be to determine if the Diocese has competence in your case. Specifically, whether (1) the marriage was held within the jurisdiction of the Diocese of Wheeling-Charleston, or (2) the Respondent lives within the Diocese, or (3) the Respondent lives outside of the Diocese of Wheeling-Charleston but the Judicial Vicar of the Respondent gives jurisdiction to the Diocese of Wheeling-Charleston after having heard from the Respondent.

As required by the Code of Canon Law of the Roman Catholic Church, the Tribunal will attempt to contact your former spouse, inform them that you are petitioner for an annulment, and will invite them to participate in the process if they so choose. They will have the right to provide testimony, propose witnesses, and have an Advocate appointed to speak on their behalf. However, you will not need to have contact with them nor will they need to have contact with you. They may also decline to participate in the proceeding which will **NOT** have a **NEGATIVE** bearing on your petition.

After this, a questionnaire will be mailed to the witnesses you named. They will respond by completing it and mailing it directly to the Tribunal. At his discretion, the Tribunal Judge assigned to your case may call you for a personal interview.
