

# Common Questions

- Do I need student phone numbers? NO
- Is it truly anonymous? YES
- Is it a lot of work? NO. After 3 weeks, average STOPit school gets ~1 report / week or less  
Messenger allows you to investigate quickly and directly
- Do you get false reports? NO. Less than 1.6% are false.  
Inappropriate users are Deactivated



# Results

- Risk Reduction: Reduced Incidents & Reduced Claims / Early Warning Signal
- Time Improvement: Reduced amount of time investigating incidents
- Community: Keep Positive School Climate in a Digital Age
